ROANE COUNTY FIRE DEPARTMENT, AMBULANCE AND LIBRARY EXCESS LEVY

Election to authorize levies for the years beginning July 1, 2017; July 1, 2018; July 1, 2019; and July 1, 2020 for the purposes of providing operational and maintenance support for the Roane County Volunteer Fire Departments, Emergency Ambulance Service and Roane County Libraries. The approximate amount to be raised is \$582,000 according to the order of the Roane County Commission entered on the 11th day of August 2016.

The levy shall be on Class 1 property 4.00 cents per \$100 of assessed value; on Class 2 property 8.00cents per \$100 of assessed value; on Class 3 property 16.00 cents per \$100 of assessed value; and on Class 4 property 16.00 cents per \$100 of assessed value.

In the event the separate and aggregate assessed valuation of each class of taxable property within the County of Roane changes during the term of the special levy, the levy rate may be adjusted so that the projected tax collection will remain approximately \$582,000 in any fiscal year.

Election to authorize levies for the years beginning July 1, 2017; July 1, 2018; July 1, 2019; and July 1, 2020 for the purpose of providing funding to purchase supplies and equipment necessary for the operation to maintain or expand the Senior Nutrition Program in Roane County as well as costs relative to the preparation and delivery of said meals and vehicle expenses throughout the county. The approximate amount to be raised is \$75,676 according to the order of the Roane County Commission entered on the 26th day of July, 2016.

The levy shall be on Class 1 property .52 cents per \$100 of assessed value; on Class 2 property 1.04 cents per \$100 of assessed value; on Class 3 property 2.08 cents per \$100 of assessed value; and on Class 4 property 2.08 cents per \$100 of assessed value.

In the event the separate and aggregate assessed valuation of each class of taxable property within the County of Roane changes during the term of the special levy, the levy rate may be adjusted so that the projected tax collection will remain approximately \$75,676 in any fiscal year.

ROANE COUNTY PLANNED APPROACH TO COMMUNITY HEALTH (PATCH) INC. AFTER SCHOOL PROGRAM

Election to authorize levies for the years beginning July 1, 2017; July 1, 2018; July 1, 2019; and July 1, 2020 for the purpose of providing personnel, supplies and equipment necessary to operate a county wide after school program that focuses on at-risk students pre-k through 12th grade through Roane County PATCH Inc. This includes before school, after school, daycare, and community development as well as costs related to the program operation. The approximate amount to be raised is \$214,000 according to the order of the Roane County Commission entered on the 12th day of July, 2016.

The levy shall be on Class 1 property 1.50 cents per \$100 of assessed value; on Class 2 property 3.00 cents per \$100 of assessed value; on Class 3 property 6.00 cents per \$100 of assessed value; and on Class 4 property 6.00 cents per \$100 of assessed value.

In the event the separate and aggregate assessed valuation of each class of taxable property within the County of Roane changes during the term of the special levy, the levy rate may be adjusted so that the projected tax collection will remain approximately \$214,000 in any fiscal year.
