OFFICIAL LEVY BALLOT

GILMER COUNTY FIRE AND AMBULANCE EMERGENCY SERVICES EXCESS LEVY

Election to authorize levies for the years beginning July 1, 2017; July 1, 2018; July 1, 2019; and July 1, 2020 for the purposes of providing operational and maintenance support for the Gilmer County Volunteer Fire Department and Emergency Ambulance Service. The approximate amount to be raised is \$241,722.00 according to the order of the Gilmer County Commission entered on the 5th day of February, 2016. The levy shall be on Class 1 property 2.36 cents per \$100 of assessed value; on Class 2 property 4.72 cents per \$100 of assessed value; on Class 3 property 9.42 cents per \$100 of assessed value; and on Class 4 property 9.42 cents per \$100 of assessed value.
