AFFIDAVIT OF APPLICANT

As an applicant for authorization to print ballots for West Virginia elections, I hereby certify under oath:

- That the applicant is an individual, partnership, association or corporation who qualifies as a resident vendor pursuant to the provisions of West Virginia Code §5A-3-37;
- That ballots printed for West Virginia elections will not be printed in a state which prohibits that state or an of its political subdivisions from contracting with West Virginia resident vendors for the printing of ballots or which prohibits the printing of ballots outside of that state;
- That all printing, packaging and delivery specifications for ballots set forth in Chapter 3 of the West Virginia Code will be met;
- That the applicant is eligible to contract for the printing of ballots in West Virginia elections in accordance with the provisions of West Virginia Code §3-1-21a;
- That the information provided on this application is true.
